The exercise will help National Operators to agree on the standards that are applicable and non-negotiable for the implementation of the programme.</p>

The presentation will give a brief background on the Seabin Project, how it came to be partnered with Butterfield Bank and ultimately, Greenrock and Eco-Schools and share the work done on plastic waste with the Seabin and beyond.</p> <p>Puerto Rico: In this presentation, OPAS will highlight the initiatives, alliances and materials that have been developed for ocean literacy in the Eco-Schools Program in Puerto Rico through several years. Further devastating events this year demonstrate the urgent need to enhance the capacities of our schools and communities to strengthen local resilience when disasters strike. This workshop will explore the role and impact of schools and communities in natural disasters, and introduces a child-centred participatory framework developed in the Indian Ocean. Through a series of practical activities which can be replicated back home, the workshop aims to provide tools which can help your schools to address DRR within their curriculums, campuses and communities, and reduce the potentially fatal impact of future disasters.</p>
